If an NRHA Lease Form has already been completed, then all that is required is that proof of that lease agreement is presented before registering for SRHA classes.

## **SRHA Non Pro/Youth Horse Lease Guidelines**

(SRHA Horse Leases will follow the rules as outlined below)

A leased horse may be shown in Non Pro and Youth competition under the following guidelines:

- (1) Prior to showing, the lessee (Non Pro) showing the leased horse, must have a lease on file at the SRHA office prior to competing.
- (2) The lease must be to an individual only. There are no restrictions to the number of times the lease can be renewed. All leases end on December 31<sup>st</sup> of the calendar year.
- (3) During the term of the lease, the lessee and his/her immediate family may show the leased horse.
- (4) A Professional SRHA member may show the leased horse in open competition.
- (5) Only one lease per horse per year will be recognized.
- (6) The lessor may not show the horse during the term of the lease.
- (7) Lessee must be a current SRHA member in good standing.
- (8) During the term of the lease, all points and/or monies earned will be credited to the lessee.

NOTE: SRHA Professionals may show a leased horse in any open competition they are eligible for, even if they are the owner (lessor) of the leased horse. Lessors with Non Pro or Youth memberships may show the leased horse in any class that has no ownership restrictions. Additionally, lessors may show the leased horse in any Open competition for which they are eligible.

## **SRHA Non Pro/Youth Horse Lease FAQ's**

### **Who can lease a horse for SRHA competition?**

o Non Pro and Youth members are eligible to lease a horse for showing purposes.

### **Do I have to send in the horse's registration or NRHA competition license?**

o Yes, the lease form and a copy of a horse registration or NRHA competition license must be turned in to the SRHA office prior to competing.

### **If I lease a horse with SRHA, can I show that horse in any class?**

o Yes, except any classes equivalent to NRHA Category 2 and 6.

### **How much is an SRHA lease?**

o A Leasing Fee of \$25 will be charged.

### **When does my lease expire?**

o All leases expire on December 31<sup>st</sup> of each year.

### **Is there a limit on how many times I can renew a lease?**

o You can renew a lease unlimited times with the SRHA, but all leases do expire on December 31<sup>st</sup> of each year.

### **If I void my lease before December 31<sup>st</sup>, can someone else lease that horse for the remainder of the year?**

o Only one lease per year is allowed for each horse.

### **Can I turn in my lease form at the show?**

o All leases must come in to the SRHA office for processing prior to competing. Please allow time for processing.

### **If I lease my horse, can my trainer still show it?**

o Yes, an SRHA Professional can compete on the leased horse in any Open Competition they are eligible for.

### **I have already turned in a lease with NRHA or AQHA, do I still have to turn a lease form in with SRHA?**

o No, but a copy of an approved lease from the NRHA or AQHA must be presented to the SRHA office prior to competing.

### **Does the Lessor have to be a current SRHA member?**

o No, only the lessee must be a member.

### **Whose ownership records get credited with the earnings while the lease is active?**

o The Lessee earns the money, points, and prizes during the term of the lease.

### **Can the owner show their horse when it is being leased?**

o Lessors with Non Pro or Youth memberships may show the leased horse in SRHA classes with no ownership restrictions.

### **Can a lease be terminated early?**

o Yes, a lease can be terminated at any time.
